MoC Update – P4 Passes

As a reminder:

- There continues to be no requirement for anyone to travel to site for the sole purpose of renewing a
 date-expired pass because the renewal paperwork will be loaded on the Pass Office system and
 remain in place until the holder is directed to return to site by their Employer/SO.
- Employers are reminded that the Personnel Security Manager(PSM) continues to seek recovery of date-expired passes as per the process detailed within the previously circulated MoC Site Notice 11-20 (which can be found on the Management of Contactors (external) website in folder "Site Notices").
- The return of a date-expired pass will not invalidate the holder's security clearance. This will be
 managed in the background by Security Vetting and there is no requirement for Employers to take
 any further action, i.e. 'clearance only' ASA's are not required.
- The PSM has previously mandated the wearing of face coverings in the Pass Office. This mandate
 has been challenged and duly retracted but please wear face coverings in the Pass Office in order
 to protect staff and customers.
